<p>OUTDOOR MEMBERSHIP ONLY – Members of the Outdoor Section have full use of the club facilities throughout the year but may not use the indoor bowling green at any time, unless as a guest (limited by club rules), or member of another club for competitions or other matches. <p>INDOOR MEMBERSHIP ONLY - Members of the Indoor Section have full use of the indoor green and club facilities throughout the year but may not use the outdoor bowling green at any time, unless as a guest (limited by club rules), or member of another club for competitions or other matches.</p> <p style="text-align: right;">£150</p> <p style="text-align: center;">Payment Due Date 1st October 2025</p>	
<p>JUNIOR MEMBERSHIP (U18) - Junior Members have full use of the club facilities throughout the year, subject only to section 7.4 of this Constitution, and may use the indoor bowling green at any time and the outdoor green between April and September at the discretion of the greenkeeper.</p> <p style="text-align: right;">£30</p> <p style="text-align: center;">Payment Due Date 1st May 2025</p>	
<p>STUDENT MEMBERSHIP – A person in full time education. Student Members have full use of the club facilities throughout the year and may use the indoor bowling green at any time and the outdoor green between April and September at the discretion of the greenkeeper.</p> <p style="text-align: right;">£30</p> <p style="text-align: center;">Payment Due Date 1st May 2025</p>	
<p>SOCIAL MEMBERSHIP - A Social member shall have the full use of the Club-House facilities.
